### DESCRIPTION OF BUILDING PRODUCT

Glasscorp Ltd supply a range of setting blocks of different sizes and profiles; manufactured with different materials including polypropylene, silicone, Santoprene TPV and PVC.

The primary function of a setting block is to correctly position and seat glazing, preventing direct contact between a glass pane and the frame. They minimise uneven surfaces, prevent vibration, and contribute to the secure and safe placement of glass.

The selection of a setting block for an application depends on different factors, including the size and type of glass unit being positioned and type of materials which may come into contact with a setting block to ensure material compatibility.
